Notes on Citation of Evidence:

When the family genealogist started to write the family history, he used Bibliography citations for his evidence from his old collage book "Writing With a Purpose". He would enter book citation of evidence diirectly into the text. The rest of the documents he would state the source of document, and where it was located. It was not entered in a citation form. This system was not flexible enough for genealogy.

He has abandon this system and taken a new citation system is a modified form of the Chicago Manual Style that supports the requirements by genealogy with more detailed source information in than other fields. The information must be analyzed as historical evidence with greater precision. Marilynne G. Ocando of Hyattsville, MD, the editor of the family history, has introduced the genealogist to this citation system.
